PENSION BENEFIT SECURITY

(Written 10-21-05 by Doug Wilsman) No word yet of Wedoff's written decision---his verbal decision was rendered on September 27th. If his written decision is the same, then we will have to wait until the legal appeals are ruled upon. If the appeals are unsuccessful, then PBGC will become the plan's trustee. It is anyone's guess how long it will take before PBGC starts sending out benefits that are reduced from the pre-termination amounts----it could be in the spring.

What follows has no impact on about 2,600 retirees and widows who will be made whole by the PBGC PC4 max guarantee according to their age on 12-30-04. For the other 3,600, I have found out the method PBGC will use to factor in the so-called "\$1.5B UAL paper" that a post-Chapter-11 UAL will deliver to PBGC. This is referred to in the statute as the "recovery." It is my opinion at this time that if PBGC established a present value of this UAL paper at \$1.5B as of 12-30-04, then it will raise the PC3 funding percentage by 9%. At this time I believe it is more likely that PBGC will establish the present value closer to \$1.0B as of 12-30-04, in which case the PC3 funding percentage will increase by about 6%.

I also believe that when PBGC starts sending out the post termination checks in a reduced amount that the impact of the recovery will not be factored in----I believe they will wait until the final benefit determinations are made about three years after becoming the trustee to start including the recovery in the monthly payments.

It is worthy of note that any retiree who will benefit from the recovery will have also benefited from the overpayments from January 1, 2005 until, say, March 1, 2006. He could then be underpaid for three years because of the absent recovery factor.

At that point, maybe March of 2009, every retiree will get an accounting from PBGC which will include the calculations of the net over-payments and under-payments since 12-30-04 and the final monthly benefit amount, retroactive back to 12-30-04. There will be a period for each individual to protest PBGC's calculations. If there has been a net under-payment, PBGC will send a lump sum including interest. If there has been a net over-payment, PBGC will reduce the final monthly amount by 10% each month going forward until it recovers the net overpayment with no interest.

To sum up, it looks like the *ultimate* 12-30-04 PC3 funding percentage is apt to be 86%. That is substantially higher than the 74% estimate I made last January----which is good news. I believe that the original post-termination amounts will be calculated using a funding percentage of 80% and after about three years the final monthly PBGC amount, retroactive to 12-30-04, will be calculated using an 86% PC3 funding.

If the legal appeals to Wedoff's decision fail, I will update my PBGC Benefit Calculator to show the impact of the latest available factors. *Doug*


SAN DIEGO RUPA LUNCHEON

EXCERPTS FROM THE TRIAL TRANSCRIPT

I have secured a copy of the 254-page transcript of the trial in Judge Wedoff's Federal Bankruptcy Court on September 21, 22 & 27 wherein he made a verbal ruling to terminate our plan as of 12-30-04. (As of this writing, his written ruling is still pending.) Obviously, it is a risky subjective exercise to select the highlights when they will be confined to a little more than a page, but here goes.

For example, PBGC's actuaries claimed its losses would increase by \$53 million if the Pilots' Plan terminated on January 1, 2005 versus two days earlier on December 30, 2004. And for a termination as of June 30, 2005, the losses were pegged to increase by \$101 million, versus 12-30-04. ALPA's actuary argued that the losses were calculated too high by PBGC and that their actuaries pegged the correct numbers at \$44 million and \$79 million. About half of the first day was devoted to this disagreement between actuaries.

The relevant federal statute is described as follows: "*PBGC is authorized by 29 U. S. Code, Paragraph 1342(a)(4) to commence proceedings to terminate a plan whenever PBGC determines that the possible long-run loss of PBGC with respect to the plan may reasonably be expected to increase unreasonably if the plan is not terminated.*"

PBGC argued that even if ALPA dollar numbers were accepted by the court the PBGC additional losses were still unreasonable. And PBGC argued it was an important element in its interpretation of the meaning of statute that the Pilots' Plan was very likely to terminate at a later date if PBGC did not seize it as of 12-30-04.

ALPA argued that in the grand scheme of things, it was not unreasonable when PBGC's out of pocket cost was \$1.4B for a 12-30-04 termination and it would go up only by \$79M for a termination 6-30-05. Over the same span UAL Ground Plan would have increased by \$287M and PBGC didn't attempt to seize it on 12-30-04. And there was nothing unusual in the increases in the Pilots' Plan between December 30 and June 30---that these increases would have occurred if UAL had not been in bankruptcy and that there were dozens of other plans out there where larger increases in liability were occurring and PBGC was not attempting a seize them.

And finally, ALPA argued that it was not necessarily likely that without a PBGC seizure the pilots plan would be terminated at UAL's request. ALPA's attorney made an impassioned plea for the judge to not assume that ALPA's promise to voice no objections if UAL sought to terminate our plan after 6-30-05 meant that ALPA supported a plan termination. Specific language to that effect was placed into the ALPA/UAL 2005 agreement.

URPBPA actuary, Thomas Levy, gave no direct verbal testimony. He referred Wedoff to two exhibits he wrote on the split/freeze. He was briefly cross examined by a PBGC lawyer about his Split/Freeze concept, where United would continue the plan for retirees and terminate it for active pilots. Levy was asked whether he had any evidence that UAL was receptive. He said no---that UAL's CFO Mr. Brace rejected it.

Then Levy said there were two ways PBGC could implement the Split Freeze: (1) it could have pressured UAL to get an agreement with ALPA to adopt the split/freeze or (2) PBGC, after it becomes trustee, can do the split and restore the retirees' half and hand it back to UAL. He wasn't asked if he believed PBGC could do that over UAL's dead body and no mention was made by anyone of PBGC agreement with UAL not to restore any terminated UAL plans. (In the judge's opening remarks he warned URPBPA that he considered the Split/Freeze plan to be irrelevant and in his verbal ruling at the end he characterized the Split/freeze as not being an alternative to termination.)

URPBPA attorney argued that if all PBGC needed to do was show that a plan's liabilities would increase over time, then PBGC could seize just about any plan, regardless of the sponsor's financial capabilities. He also argued that the increases in our plan's liabilities in the first six months of 2005 had probably occurred in the same magnitude in prior years and PBGC didn't attempt to seize the plan then.

United had an attorney at the trial who made an opening statement and was not heard from thereafter. She stated that UAL believes that all of its plans must be terminated, and UAL reserves its right to seek a later termination, depending on the outcome of this litigation.

Near the end of the closing arguments on September 22, Wedoff made a profound statement that, in my view, telegraphed his verbal ruling on September 27. He said that it was obviously in PBGC's best self-interest not to terminate plans that don't need to be terminated. He agreed with PBGC's argument that the statutory requirement of an "unreasonable increase" might incorporate the notion that the plan was likely to terminate.

In his verbal ruling on the 27th, he said an "unreasonable increase" as provided in the statute is a situation where there is both a substantial increase in the dollar amount and a likelihood that the plan will eventually require termination. He said he believes PBGC had successfully established both of these elements during the trial. *Doug*

TOP HOAXES OF ALL TIME

PLANETARY ALIGNMENT DECREASES GRAVITY

In 1976 the British astronomer Patrick Moore announced on BBC Radio 2 that at 9:47 AM a once-in-a-lifetime astronomical event was going to occur that listeners could experience in their very own homes. The planet Pluto would pass behind Jupiter, temporarily causing a gravitational alignment that would counteract and lessen the Earth's own gravity. Moore told his listeners that if they jumped in the air at the exact moment that this planetary alignment occurred, they would experience a strange floating sensation. When 9:47 AM arrived, BBC2 began to receive hundreds of phone calls from listeners claiming to have felt the sensation. One woman even reported that she and her eleven friends had risen from their chairs and floated around the room.

THE PREDICTIONS OF ISAAC BICKERSTAFF

In February 1708 a previously unknown London astrologer named Isaac Bickerstaff published an almanac in which he predicted the death by fever of the famous rival astrologer John Partridge. According to Bickerstaff, Partridge would die on March 29 of that year. Partridge indignantly denied the prediction, but on March 30 Bickerstaff released a pamphlet announcing that he had been correct: Partridge was dead. It took a day for the news to settle in, but soon everyone had heard of the astrologer's demise. On April 1, April Fool's Day, Partridge was woken by a sexton outside his window who wanted to know if there were any orders for his funeral sermon. Then, as Partridge walked down the street, people stared at him as if they were looking at a ghost or stopped to tell him that he looked exactly like someone they knew who was dead. As hard as he tried, Partridge couldn't convince people that he wasn't dead. Bickerstaff, it turned out, was a pseudonym for the great satirist Jonathan Swift. His prognosticatory practical joke upon Partridge worked so well that the astrologer finally was forced to stop publishing his almanacs, because he couldn't shake his reputation as the man whose death had been foretold.

UFO LANDS IN LONDON

On March 31, 1989 thousands of motorists driving on the highway outside London looked up in the air to see a glowing flying saucer descending on their city. Many of them pulled to the side of the road to watch the bizarre craft float through the air. The saucer finally landed in a field on the outskirts of London where local residents immediately called the police to warn them of an alien invasion. Soon the police arrived on the scene, and one brave officer approached the craft with his truncheon extended before him. When a door in the craft popped open, and a small, silver-suited figure emerged, the policeman ran in the opposite direction. The saucer turned out to be a hot-air balloon that had been specially built to look like a UFO by Richard Branson, the 36-year-old chairman of Virgin Records. The stunt combined his passion for ballooning with his love of pranks. His plan was to land the craft in London's Hyde Park on April 1. Unfortunately, the wind blew him off course, and he was forced to land a day early in the wrong location.

KREMVAX

In 1984, back in the Stone Age of the internet, a message was distributed to the members of Usenet (the online messaging community that was one of the first forms the internet took) announcing that the Soviet Union was joining Usenet. This was quite a shock to many, since most assumed that cold war security concerns would have prevented such a link-up. The message purported to come from Konstantin Chernenko (from the address chernenko@kremvax.UUCP) who explained that the Soviet Union wanted to join the network in order to "have a means of having an open discussion forum with the American and European people." The message created a flood of responses. Two weeks later its true author, a European man named Piet Beertema, revealed that it was a hoax. This is believed to be the first hoax on the internet. Six years later, when Moscow really did link up to the internet, it adopted the domain name 'kremvax' in honor of the hoax.

TEN RULES FOR SAFER DRUG USE

Rule 1: Have "Brown Bag Sessions" With Your Primary Doctor and Fill Out A Drug Worksheet.

It is impossible to overemphasize the importance of this first and most crucial step in preventing adverse drug reactions. Whenever you go to a doctor you have not previously seen or to one with whom you have never had a brown bag session, put all prescription and over-the-counter drugs you are using, have used in the last month, or are likely to use in a bag, and bring them to the doctor so a list can be made and you can start to fill out your drug worksheet with the names of drugs you're taking, the prescribing doctors, the reasons you're taking them, dosages, possible reactions, possible interactions and other information. (A Drug Worksheet is included with WORST PILLS, BEST PILLS).

Doctors should never prescribe a drug or renew a prescription, nor should you be willing to get a new prescription, without full up-to-date knowledge of all drugs already being taken or likely to be taken. And that includes over-the-counter drugs.

Rule 2: Make Sure Drug Therapy Is Really Needed.

Ask your doctor to explain all the alternatives, and the pros and cons of each. The guiding principle is to use as few drugs as possible, in order to reduce adverse reactions and increase the odds of properly taking the ones that are really necessary.

Rule 3: If Drug Therapy Is Indicated, In Most Cases, Especially in Older Adults, It Is Safer To Start With a Dose That Is Lower Than the Usual Adult Dose.

"Start low, go slow." The lowest effective dose in any patient is always the best, because a lower dose will cause fewer adverse effects, which are almost always related to dose. In the elderly, some experts suggest starting with one-third to one-half of the usual adult dose for most drugs and watching for side effects, increasing the dose slowly and only if necessary to get the desired effect.

Rule 4; When Adding a New Drug, See If It Is Possible to Discontinue Another Drug.

If your doctor is considering the addition of a new drug, this should always be used as an opportunity to re-evaluate existing drugs and eliminate those that are not absolutely essential. The possibility of an adverse drug interaction between the new drug and one of the old ones may force dropping or changing a drug.

Rule 5; Stopping a Drug Is As Important As Starting It.

Do not take a drug any longer than is necessary.

Rule 6; Find Out If You Are Having Any Adverse Drug Reactions.

Even before you have a brown bag session with your doctor, if you develop any of the following reactions after beginning to use any drug, contact your doctor. Ask if you really need a drug in the first place and, if you do, whether a safer drug can be substituted or whether a lower dose could be used to reduce or eliminate the adverse effect.

Mental Adverse Drug Reactions: depression, hallucinations, confusion, delirium, memory loss, impaired thinking, and insomnia.

Nervous System Adverse Drug Reactions: parkinsonism, involuntary movements of the face, arms, and legs (tardive dyskinesia), dizziness on standing, falls (which can sometimes result in hip fractures), automobile accidents that result in injury because of sedation, and sexual dysfunction.

Gastrointestinal Adverse Drug Reactions: loss of appetite, nausea, vomiting, abdominal pain, bleeding, constipation, and diarrhea.

Urinary Tract Adverse Drug Reactions: difficulty urinating or loss of bladder control (incontinence).

If you or a relative or friend have any of the above problems or develop other problems arising after starting a new drug, notify your doctor or tell your friend or relative to notify his or hers.

[WORST PILLS, BEST PILLS includes adverse reactions associated with drugs you may be taking.]

Rule 7; Assume That Any New Symptom You Develop After Starting a New Drug Might Be Caused By the Drug.

If you have a new symptom, report it to your doctor.

Rule 8; Before Leaving the Doctor's Office or Pharmacy, Make Sure the Instructions for Taking the Medication are Clear to You and a Family Member or Friend.

The chance of adverse reactions is high enough that at least one other person—a spouse, child, or friend—should know about these possibilities.

Rule 9: Discard All Old Drugs Carefully.

Avoid the possibility that they might be taken inadvertently.

Rule 10; Ask Your Primary Doctor to Coordinate Your Care and Drugs.

If you see a specialist and he or she wants to start you on new medicines in addition to the ones you are on, check with your primary doctor first—usually an internist or general or family practitioner. It is equally important to use one pharmacist, if possible.

LOW CHOLESTEROL IS DANGEROUS?!

By Dr. Bruce West

Low cholesterol, especially in older people, correlates with an increased risk of death. People suffering from diseases like AIDS, chronic fatigue, and cancer very often have very low cholesterol readings. It is now indisputable that for those people approaching old age— 75 years and older —low cholesterol is a very, very bad finding. This seems unbelievable because doctors, even at these later ages, still continue to try to lower cholesterol with drugs.

If lowered cholesterol in older ages carries a higher risk of death, doesn't it make sense that the earlier you start on drug-therapy to lower cholesterol, the higher your risk of death would be? My experience definitely shows this, but the **Honolulu Heart Program** study truly makes it clear. Published in the August 2001 issue of *The Lancet*, Vol. 358, No. 9279, this quote from the program really sums it up:

"Our data accord with previous findings of increased mortality in elderly people with low serum cholesterol, and show that long-term persistence of low cholesterol actually increases the risk of death. Thus, the earlier patients start to have lower cholesterol concentrations, the greater the risk of death."

In case you didn't catch that fully, the study findings showed the following: The information discovered about low cholesterol was the same as most all other cholesterol studies. That long-term lowered cholesterol in older people increases the risk of death from all causes. And the earlier you start to have lower cholesterol, the greater your risk of death.

If You Are Sick, Keep Your Cholesterol Up

Normal cholesterol levels run around 150 to 250, but thanks to the pharmaceutical push, doctors are trying to get cholesterol down around 80 to 130— a dangerous proposition for sure. It is at values around 100 or lower that people with serious deteriorating diseases and cancer succumb.

If you have cancer or any other serious infectious disease, you need to check your cholesterol level. If it is below 130 you are in trouble. If you are also taking statin drugs and your cholesterol is this low, ask your doctor to stop this prescription ASAP. Your life could depend upon it. The best way to tell if low cholesterol is contributing to ill health is a simple assessment of how you feel— especially how you feel while on statins vs. how you feel after 90 days off the drugs.

If you stop the drugs and feel much better, you need to get your cholesterol back up to normal. And that can be tough, especially if you are very ill. You will need to eat a traditional diet with lots of egg yolks, whole milk, butter, cod liver oil, bone broth preparations and more. Even then it could take a couple years to get your cholesterol levels back up.

Cholesterol is Essential

And remember, when sick you are under stress, and stress hormones are made from cholesterol. Also, your brain is made of large quantities of cholesterol. And you can't have healthy bones without cholesterol transformed to vitamin D in your skin by the sun. In other words, the vitamin D needed for strong bones is made from cholesterol. Indeed you can't live without plenty of good cholesterol —and the statistics of older folks and those with serious diseases now prove this indisputably.

If Your Cholesterol is Naturally Low

If your cholesterol is critically low and always has been— without drugs —this is another situation altogether. I have to imagine that low cholesterol is genetically normal for some people. But having said this, when I see a patient with cholesterol below 130, I take notice. While there may be no apparent problem or disease, the possibility of premature death is certainly real.

If this is you, make sure there isn't undiagnosed liver disease; blood tests can usually make this determination. Make sure you are not doing regular fasts, severe and repeated detoxification procedures, too many bowel cleanses, juice diets, taking too many herbs, avoiding meat and meaty broths, and living only on sprouts, grains, fruits, seeds, and vegetables. These kinds of habits combined with low cholesterol can lead to "wasting" diseases.

It is always best in these cases to start on a more traditional diet. A tablespoon of raw cod liver oil daily (Carlsberg makes the best) is in order. If cholesterol stays very low, start on nine *Livaplex* (by Standard Process) daily. Allow two years or more for complete recovery.

Physicians' Accountability

Today well-meaning physicians are forcing cholesterol levels to extreme lows by inhibiting the liver's ability to produce this much-needed substance. This may help to prevent a few heart attacks, although even this is subject to controversy. By starting people toward cholesterol levels below 130 earlier and earlier, one must ask just how many thousands of cases of cancer, other diseases, and deaths are being caused.

As doctors, we need not look much farther than our own experience with people wasting away and dying early while reducing their cholesterol. If this isn't enough evidence, we need only look at the medical literature itself to make this connection.

What is a Traditional Diet?

DANGEROUS FALLS PLAGUE SENIOR DIABETICS

With the links between diabetes and disease states such as obesity Alzheimer's disease and depression so clear, it's no wonder senior diabetics -- **particularly those living in a nursing home or assisted living setting** -- are more prone to dangerous falls.

The numbers really speak for themselves: Out of 139 nursing home patients monitored for some 300 days, **78 percent** of those who suffered from diabetes fell. Conversely, only **30 percent** of residents without diabetes experienced a fall.

Why the increase in falls by diabetics? Researchers believe diabetic patients have problems with the peripheral nerves that affect sensations in their feet, thus making them far more likely to fall.

Falls are **the leading cause of accidental death** among seniors in this country (baby-boomers are starting to fear them too), but they can be avoidable.

Probably the best way to prevent falls is one of the simplest: Get moving on an exercise program today! If you need some guidance on how to get started, I recommend reviewing Paul Chek's Awesome piece on balance training for the elderly. http://www.mercola.com/2005/apr/9/balance_training.htm

My 78th was on May 2 (Letter 5 mos. late). Not only the usual procrastination, but I wanted to write, what I think will be a newsworthy letter.

My grandson, Lance Corporal Andrew Chambers, U. S. Marine Corp Reserve, was called back to active duty on June 1, 2005. He had been trained at The Army Artillery School, Ft. Sill, OK as a forward controller. Since the Marines were short of troops and no need for forward artillery controllers, he was retrained for door-to-door and hand-to-hand combat.

"Drew" has now been in the Al Anbar Province between Ramadi and Fallujah for about 6 weeks. He had been assigned to the Cleveland area military reserve unit, which has had about 50 men killed--which is more than any other unit in the U.S.



That unit is now supposed to be on their way back to Cleveland. Drew is now with a different unit. I will forward a picture of him standing guard over 6 captured terrorists, who are sitting along the highway, handcuffed and blindfolded. Their weapons are laying on the ground in front of them. The picture was sent to me by e-mail. A friend enhanced the picture and printed it on photo paper. It is now a very good quality picture. (I will mail a glossy print.) I want to explain a provision of the BUSH "NO CHILD LEFT BEHIND ACT of 2001". Most parents are unaware of SECTION 9582, which states that high schools must permit military recruiters in high schools, or the school will lose Federal Funds. A little known provision is that parents must notify the school in writing if they do not want their child solicited to join the military service.

The NO CHILD LEFT BEHIND ACT is a misnomer. In the case of Drew, he is now 3 college years behind his high school peers. If he returns from Iraq next year, he will be 4 years behind in getting a college education. I began a college fund for all of my grandchildren when they were very young. Two of my grandsons have graduated from U. C. San Diego, my granddaughter is a sophomore at UCLA and Drew's younger brother is at Cal-State Fullerton. I am very much against recruiting children in high school when they are very naïve and believe what the recruiters tell them. I was in the Navy during WWII, became a high school teacher and later a USAF pilot during the Korean War. I earned a Doctorate in Education from UCLA in 1969. It was very difficult to do around a constantly changing flight schedule and low seniority.

During the Korean War, I accompanied the remains of a very good friend, Lieutenant Jake Friend for burial in Arlington National Cemetery and 3 days with his grieving mother and siblings in Romney, WV.

His mother clawed at the casket after it was brought into the house to get one last look at her son.

My other best friend Lieutenant John P. Shaddick III was with me in USAF Pilot Training Class 51-D and later in B-29 Combat Crew Training. John was shot down on his first mission to bomb power plants in North Korea on the Yalu River. By coincidence, one of our classmates from 51-D was

assigned to a Search and Rescue mission and dropped a radio to him. He identified himself by stating the name of the dog mascot at Reese AFB, Lubbock, TX.

Three attempts were made to pick him up, but fire from the ground then placed the rescue team at great risk and the attempt was abandoned. John was later seen in a prison camp. He was not exchanged at the Panmunjom prisoner exchange in 1954. His name was one of 450 whose names appeared in the Congressional Record of men missing in action and never accounted for. I later met with John's mother in Coral Gables, FL and she told me how badly she was treated by the State Department. She had bought an airline ticket to Seoul, Korea and was in a position to pay ransom for John's return. The State Department lifted her passport, when changing planes in Hong Kong and prevented her from going to Seoul. Now two generations later, I cannot help but wonder what the fate of Drew might be and the horrors of war haunt me every day.

The flotilla returned to the SYC about 12:00 pm to be greeted by a Marine detail, in dress blues, consisting of a Captain, Sergeant and a Corporal. All veterans of the Iraq war.

Invited guests started to arrive about 12:30 and a flag folding ceremony followed shortly thereafter culminating with the Marine Captain presenting the folded American flag to Patty, with the statement "This flag is presented to you, Mrs. Melin, on behalf of the President of the United States for Captain Melin's service to his country". Not many dry eyes in the crowd. A hosted bar then opened and everyone mingled over appetizers and drinks.

At 1:30 pm Cort gave a brief welcoming statement and a heart felt tribute to his best friend. This was followed by Steve Mainwaring (his oldest friend) giving a 40 minute roast starting with their college years through retirement.

Approximately twelve others stepped forward to the microphone, gave tribute and told stories of their own experiences and friendships with Mike.

There were about 300 people in attendance which is apparently the largest memorial in the history of the Sausalito Yacht Club. A tribute of how much Mike meant to all of his friends.

Near the end of the speeches, the Blue Angels, practicing for the "Fleet Week" celebration on the San Francisco Bay, flew over the Yacht Club in what appeared to be a missing man formation.

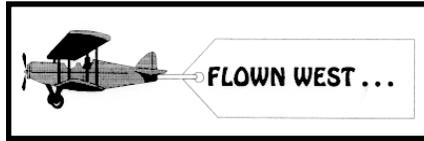
