1-800-UAL-LIST, NEW AND IMPROVED

The automated, voice-activated telephone system for booking employee and companion travel, 1-800-UAL-LIST, has been upgraded to make it easier to use.

- * In response to feedback from employees, an improved call-flow design, better speech recognition, a new voice and reduction of background-noise interference have all been incorporated into this new, enhanced product.
- * In addition, companions can now make date and flight number changes to space-available listings, and check flight loads. Note that the sponsoring employee still must do the original booking for companion travelers.
- * Employees can continue to plan travel and list for flights on SkyNet, however 1-800-UAL-LIST gives employees an option when they are unable to access the Internet.
- * Access to the system within the United States is free. International direct dialing rates apply for calls made from outside the United States.
- * The service can be used for both non-revenue space available (NRSA) and non-revenue positive space (NRPS) travel.

Employees who have not tried 1-800-UAL-LIST, or those who haven't used it in awhile, are encouraged to use this improved employee tool when booking NRSA and NRPS travel.

2007 RUPA CONVENTION TOURS

The members of the *Seattle Goonevbirds* have selected a number of tours for our enjoyment for his years Convention. All of the tours will be operated by the Seattle Gray Line Tour Company. All of the tours will be on 47 passenger busses and will require a minimum of 32 passengers per tour for the tour to operate. Please keep this in mind when you sign up for a tour. If there are not enough passengers signed up for a certain tour, you may be moved to your second choice. The buses we will be using do have restrooms. We plan to have four tours on Friday, four tours on Saturday and two tours on Sunday. The Sunday tours will arrive back at the hotel in plenty of time for you to relax and freshen up before attending the Banquet. Some walking will be involved in each of the tours so be sure to have comfortable shoes. On Sunday the 23rd we will have our Farewell Banquet and general meeting. After dinner we will have a short talk by Dr. Bonnie Dunbar. Dr. Dunbar became a NASA astronaut in August 1981. She is a veteran of five space flights, and has logged more than 1,208 hours (50 days) in space. We hope you will be able to attend her most interesting presentation. We only had eight players sign up for golf at our last Convention. If you wish to have a golf tournament at this Convention, let us know well in advance so one can be set up. The price for the Seattle City Sights Tour has been reduced from \$38.00 to \$30.00 and the tour shortened to 4 hours so the people on the tour could get back to the hotel in time for the General Meeting. Friday, Sept. 21.

The Boeing Everett tour \$43.00. – **Depart the Hotel at 9:30 am.** Leave the hotel in the morning for the Boeing Future of Flight Tour. The Future of Flight Aviation Center is a cutting-edge facility featuring 28,000 square feet of interactive aviation exhibits. You will watch a brief moving about Boeing in the Boeing Theater, then travel a short distance to the Boeing factory where you enter the world's largest building by volume (472 million cubic feet of space). We will view the assembly line for the 747 and the 787. This is a 4 hour tour, including travel time; lunch will be available at the company cafeteria at your expense.

Tacoma Museums Tour \$55.00. –**Depart the Hotel at 9:00 am.** Depart the hotel and travel to the Greater Tacoma Museum District, where you will be able to enjoy the Museum of Glass, the Tacoma Art Museum and the Museum of Natural History. Admission to all three Museums is included with this tour. Lunch will be on your own. This is a 6 hour tour, including travel time.

Tillicum Village Dinner Cruise \$98.00. –**Depart the Hotel at 3:30.** This is an evening tour. The bus will depart the hotel and deliver you to the Argosy Cruises dock on the downtown waterfront to board the vessel which will take you to Blake Island. Tillicum Village is a Northwest American Native Site. In the Chinook language, "Tillicum" means "friendly people". Here you will enjoy a meal of salmon cooked on cedar stakes over an open fire. It will be served in a traditional cedar longhouse, surrounded by Northwest Coast native crafts and artwork. After dinner you will be entertained with ceremonial dances, myths, and legends of the native culture. This is a 5 hour tour.

Cruise the Locks Tour \$68.00. –Depart the Hotel at 11:00. Seattle is a city of meandering waterways – from Puget Sound to Lakes Washington and Union. Enjoy the scenery and lively narration as your guide tells you all about Seattle's maritime highlights on this Argosy boat tour. The bus will pick you up at the hotel and will join the Locks Cruise Vessel at its departure point. Lunch is on your own. This is a 4 hour tour.

Saturday, Sept. 22.

Museum of Flight Tour \$33.00. –**Depart the Hotel at 9:00 am.** Depart the hotel for the Seattle Museum of Flight, the largest air and space museum in the West. You may take a tour through the museum with a docent if you wish or proceed on your own. There are more than 150 historic air and spacecraft, interactive exhibits, personal stories and educational activities to view. Also visit the William E. Boeing Red Barn., the original manufacturing facility of the Boeing Airplane Company, or browse the Personal Courage Wing, home to an impressive collection of WWI and WWII fighter planes and war memorabilia. Lunch is available on your own at the cafeteria. This is a 4 hour tour.

Woodinville Winery and Brewery Tour \$45.00. –**Depart the Hotel at 10:30.** You will depart the hotel and travel to the Woodinville Wine District, where you will enjoy tours and tasting at the Columbia Winery, Chateau Ste Michelle and the Redhook Brewery. Admission to the tasting locations and tasting fees are included in this 5 hour tour.

Royal Argosy Dinner Cruise \$120.00. – **Depart the Hotel at 6:00 pm.** This is another evening tour. You will be picked up at the hotel and delivered to the Argosy Cruises dock on the downtown waterfront. You will enjoy dinner while cruising on Elliot Bay and viewing the Seattle skyline at night. SW FLORIDA RUPA MEETING

March 12, 2007

Clear skies and warm temperatures greeted the *SW FLA RUPA* group who managed to make their way through the traffic of snowbirds and spring breakers to the *Olive Garden* for our monthly meeting.

Turn out was one of the largest of the season. Featured speaker was Mr. David Helms, pilot, author and theorist on the fate of Amelia Earhart. Mr. Helms related the facts relating to the final leg of Amelia's around the world flight in 1937. He constructed the probable chain of events that lead to the fatal flight. An earlier attempt ended with an accident while taking off in Hawaii and the aircraft was returned to the States for repairs. Two of the crew elected not to go along on the next attempt. One was an expert radio operator. Link one. Link two was fatigue, Earhart and Noonan had been flying for four weeks and 22,000 miles. On take off from Lae, New Guinea, the Electra was 5,000 lbs over gross then early in the flight clouds forced Amelia to climb to 12,000', this ate into her reserve fuel, link three. Next the head winds were stronger than forecast, more reserve gone, and link four. Arriving in the Howland Island area early in the morning was probably not conducive to sighting a small flat island, link five. Howland Island was charted about six miles short of its actual position, link six. Finally Amelia was not well trained in the use of the latest radio equipment she had on board.

Mr. Helms believes that Amelia ditched at sea somewhere on a 25-mile wide arc 15 to 45 miles north west of Howland Island.

Seems like time is flying by at jet speed anymore, I didn't do much this Year but did build three more longaberger baskets at the factory four Miles northwest of Dresden, Ohio for a total I've built now of 30, why do I do that? For fun of course and to give them away as presents! If you get a chance to stop by there be sure and see their corporate headquarters on the east side of Newark, Ohio, it's the largest basket you will ever see!!

Remembering years ago is what we do best isn't it, may I tell you about a parachute jump I made in February of 1966, I was flying co-pilot on the DC8 with Captain Glen Gronquist, if you have flown with Glen you know he was a fine pilot, a fine gentleman, and an airplane nut ! I have permission from Glen's wife Marie to tell this story! Glen would probably have never jumped from an airplane but he knew about the old barnstorming parachutists and he was interested in watching me jump from his Fairchild 22 to see just how it looked from the top end!!! I was delighted as a part of the fun of parachuting is the different aircraft to jump from and I had never jumped from a Fairchild 22 before!! We arranged to meet on February 16th, 1966 at the Sonoma County Airport, Schelville, California!! My dad flew with me in my airplane, (an Aeronca Champ) to the airport and of course I had my two parachutes packed and ready to unpack in the air!!! The main parachute was a surplus navy all white 32 foot round canopy that I had dyed a deep blue color with Rit dye in my bathtub, a common way of putting some color into the sky at the time!!. It had been modified to an inverted double tee modification and I could get maybe 8 miles an hour forward push from it if I was lucky, fortunately that day the winds were about 8 mph!!!

Glen owned the airplane with Sherwood Verger and both Glen and Verge were there when my dad and I arrived, Verge wasn't sure this was a good idea but Glen and I were eager, I looked at the front cockpit and realized there was no way I could get in that cockpit with my parachutes on, but I told glen it would be no problem if I sat on the gear strut side saddle on the takeoff and climb and I didn't think the extra drag would be a problem for the airplane. Glen said, "Put your parachutes on and let's see how it looks!!!" So in minutes I had my parachutes on and was sitting on the gear strut hanging onto the wing strut with a big smile on my face, I'm sure and Glen said, "Let's go!!!" Hot dog, it was my 221st parachute jump!! Verge propped us and we taxied to the end of the runway, Glen ran the engine up, and away we went!!! The airplane jumped off the ground and I could see already this was going to be a fun ride that you can't get at the County Fair!!! No problem climbing, at 1800 feet I was looking at Glen when there was a very loud noise and a piece of carbon, I thought, went between my helmet and the wing strut only a few inches away and barely went a few inches below the horizontal stabilizer, I looked back at Glen and he was stretching looking out his cockpit forward and I looked that way and lo and behold there was a spark plug lead flapping in the breeze. That was a sparkplug that just flew by my head, the one aimed right at my helmet, fortunately for me, it missed!!! Ha! I leaned forward and yelled to Glen to head for the middle of the airport, he did, and we were at 2300 feet having climbed 500 feet minus one each spark plug!!! I have had adverse reactions to about a third of my prescriptions.

Since flying is out of the question I bought a Lotus sports car. Rosa and I go up in the mountains and scare the hell out of motorcyclists. It really keeps the arteries open.......Highly recommended!

SAY GOODBYE TO HEARTBURN — PERMANENTLY!

If you are one of the millions of adult Americans with heartburn, this report is sure to bring you great hope. I'm going to tell you about a safe and incredibly effective option that can rid you of heartburn for good.

You read that right! A Brazilian study has shown that you can completely eliminate heartburn (also known as GERD - gastroesophageal reflux disease) with some common and inexpensive dietary supplements.

In the study, Dr. Ricardo Pereira followed 351 patients with heartburn. They entered his surveillance program between January 2001 and December 2005. Their average age at the beginning of the study was 44 years, with a range from 18 to 88 years. And 60 of them were women. The study was single blind. That means that the subjects themselves did not know what they were receiving, but the researchers did. Participants had to have moderate to severe heartburn or regurgitation at least weekly. They were divided into two separate groups. The group with 175 subjects received supplements. The second group, with 176 participants, received a popular proton pump inhibitor (omeprazole — 20 mg daily).

Participants kept symptom diaries on a scale of 0-4. Zero was no pain, and 4 was terrible pain. With only seven days of treatment, the subjects taking the dietary supplements had some relief of their symptoms. After 40 days, 100 of the nutritionally supported subjects said their symptoms were gone!

The people on the drug didn't fare nearly as well. Yes, after nine days of treatment, the subjects taking omeprazole reported marked improvement in symptoms. But after 40 days, only 65.7% of subjects said their symptoms were gone. Another 2.3% reported partial relief. And the remainder continued to experience symptoms as bad as they were before treatment.

And, as expected, those taking the drug had more side effects. Two subjects in the omeprazole group withdrew from the study because of persistent headaches. The supplement group also experienced one side effect — somnolence or sleepiness, which occurred in almost the entire group (90.3%).But none of them complained, as the supplements actually improved their sleep.

So what was the magic concoction? Dr. Pereira combined the supplements melatonin (6 mg daily), Ltryptophan (200 mg daily), vitamin B6 (25 mg daily), folic acid (10 mg daily), vitamin B12 (50 mcg daily), methoinine (100 mg daily), and betaine (100 mg daily). Dr. Pereira named the concoction Tripiridardo.

Why did he use melatonin? It inhibits gastric acid secretion and nitric oxide (NO) synthesis. NO relaxes the sphincter muscle that protects your esophagus from the acid. When the sphincter relaxes, it allows acid to escape from your stomach. Melatonin might help keep your sphincter tighter by reducing NO. Melatonin can also cause sleepiness, the one effect noted from the supplement group.

The other supplements may work by reducing inflammation and pain and promoting healing.

Here's an example of how well the combination works: One male patient in the study weighed 176 pounds before developing an esophageal ulcer due to GERD. He quickly lost half his weight to 88 pounds. After 32 days of treatment with the nutrients, he had recovered 66 pounds to 154 pounds. After nine months of treatment, his weight was back to 176 pounds. And endoscopy proved that the ulcer had vanished!

This is huge news. Millions of Americans suffer from this nagging condition with no relief. All they can do is pop petrochemical drugs or down antacids. Now we have evidence that a safe combination of supplements might stop your pain and literally heal the condition.

You know it would be a lot cheaper to study and test supplements than toxic drugs. But that's just not going to happen. Big Pharma gets its profits from patented synthetic petrochemicals. And their ONLY motivation is profit - not truth or service to you. If this news gets out in a big way, it might not be too long before melatonin is removed from the shelves. After all, it could wipe out a multibillion dollar class of chemical medicine.

When I talked to Dr. Pereira, he said, "These results demonstrated clearly that the Australian scientists who got the Nobel Prize of Medicine in 2005 are completely WRONG when they said that ulcers are healed with antibiotics and omeprazole (or other proton pump inhibitors)."

He added that all "my research was done with my own money because the Brazilian Government Agencies are bankrupted."

How many of us in alternative medicine can afford to do research like this? We just can't. Dr. Pereira is a saint. I hope that further studies on his formulation can be conducted. Do you think that the Nobel committee will award him with the world's most prestigious prize for curing the condition with common nutrients?

If you're suffering from reflux, consider these supplements as an alternative to your pain or your prescriptions. A healed stomach would be a lot nicer than a lifetime of an expensive and possibly dangerous chemical. I'd suggest taking it before bed to maximize your benefit from the melatonin. If you do try the combination, please be sure to drop me a line and let me know how it works for you.

The information below was posted on the Delta Pilots Forum.

THE NEXT BIG DRUG SCANDAL THREATENS YOUR BONES —

EVEN IF YOU'RE A MAN

You were some of the first people in the country to know about the problems with Vioxx. I told you about the drug's problems years before anyone else knew about it. You were also the first to know about the problems with statins. That debacle has yet to unfold in the news media. But it will. And you can tell everyone you knew about it years before it happened.

Now there's another drug that's going to take a huge hit. I told you about its potential problems several years ago. The story has yet to hit the mainstream. But trust me, it will. This one is simply too big. In fact, it's a bigger story than Vioxx and statins. That's because this story is about the most widely prescribed drugs on the market — antacids.

Thanks to a new study, researchers now know that these drugs, which doctors dole out like water for heartburn, stomach acid, reflux, and indigestion, significantly increase your risk for osteoporotic hip fractures.

Dr. Yu-Xiao Yang of the University of Pennsylvania School of Medicine, led the study. And, amazingly, it was published in the widely read Journal of the American Medical Association. His group followed a large British database to identify 13,566 patients over 50 with hip fractures. They compared these to a matched group of 135,386 healthy people.

Their research found that just one year of using these drugs increases your risk of hip fractures by 44%. But it gets worse. Long-term users who were given higher doses had as much as 260% the normal risk.

And men weren't immune. In fact, they were at an even greater risk. They had about twice the risk of suffering a hip fracture as did women. That's likely because men don't think about osteoporosis as much as the gentler sex. So they're less likely to take calcium or other supplements to stop bone loss.

Why do antacids cause such a big jump in risk? The first part of the answer is simple. But for some reason (money), Big Pharma doesn't get it. The drug companies think God made a mistake when He created your stomach to make acid. He didn't! He put the acid there for a reason. Acid is essential to pull off and dissolve alkaline minerals, such as calcium, from your food. Without acid, you just won't absorb calcium well. That right there is enough to explain the link to osteoporosis.

However, there are lots of other minerals that are acid-dependent for absorption. If the scientists looked, I'm sure that they'd find deficiencies in zinc, manganese, and copper - all of which are induced by blocking mineral-digesting acids. They'd probably find vitamin B12 problems as well. That critical nutrient must have a functioning stomach for absorption.

However, mineral deficiency isn't the drugs' only link to osteoporosis. And most people missed this when they looked at the study. One of the hottest new forms of antacid is called the proton pump inhibitors. The name comes from their action on the body — they inhibit the pumps inside cells that secrete protons into your stomach's cavity.

Not surprisingly, the proton pump inhibitors don't just selectively single out your stomach cells. They'll hit all cells that have proton (acid) pumps. One key cell is the osteoclast, the cells that resorb old bone. These cells make and secrete acid to dissolve away old inflexible bone to make way for new vibrant bone. This is

called bone remodeling. It's absolutely essential for a healthy skeletal system. Certain osteoporosis drugs kill off osteoclasts. Since old bone isn't removed, your bones do get denser. But they also get more brittle.

Here's the moral of the story: All drugs are designed to block a function (block pain, acid, blood pressure, fever, etc.). When your doctor recommends a drug, find out what its biochemical mechanism of blocking is. Then study what that blocked function was doing to your body's functions — or ask your doctor to tell you.

If you do have heartburn, reread last month's issue. In that issue, I told you how you can get rid of heartburn permanently. [*Article is in this issue.* -Ed.] I told you how you can use the supplements melatonin (6 mg daily), L-tryptophan (200 mg daily), vitamin B6 (25 mg daily), folic acid (10 mg daily), vitamin B12 (50 mcg daily), methionine (100 mg daily), and betaine (100 mg daily) to fight heartburn.

You can also use natural stomach strengthening remedies such as comfrey, ginger, DGL, curcumin, and aloe.
